

**ORDER FOR ATTORNEY'S FEES PAYMENT  
AND DISMISSING THE CASE WITH PREJUDICE**

The Court, having reviewed the Plaintiff's Motion for Fees served on the Defendant, the statement of services rendered, the court file and the court being fully advised in the nature of the issues, the difficulty of the representation of the Prison Legal News (PLN) against the GEO Group, Inc. (GEO) and the time the litigation took place, the court hereby finds:

Frank Kreidler is the attorney for Plaintiff. The Plaintiff is the prevailing party. He has submitted a motion for attorney's fees reflecting his time records and his hourly rate of \$400.00 per hour.

Since the Defendant did not produce the public records requested first in 2005, a fee of \$40,000.00 is fair and reasonable in this case as the prevailing party. The Defendant finished completing the public records production on December 11, 2009, completely complying with the Plaintiff's request.

**IT IS ORDERED AND ADJUDGED THAT:**

The GEO Group, Inc. shall pay to Frank Kreidler, Esq., the amount of \$40,000.00 within fifteen (15) days of the entry of this order. Each party shall bear all of their other fees and costs.

The court reserves jurisdiction to enforce the terms of this agreed settlement.
