NINTH AMENDMENT TO THE AGREEMENT FOR JAIL MEDICAL SERVICES AT COOS COUNTY, OREGON (Effective August 1, 2016)

This Ninth Amendment (this "Amendment") to the Agreement for Inmate Health Care Services dated July 1, 2009, as amended (the "Agreement"), is by and between Conmed, Inc. (hereinafter, "Conmed") and Coos County, a political subdivision of the State of Oregon, acting by and through its Board of Commissioners (hereinafter, the "County").

WHEREAS, the Parties have determined that it is necessary and in the best interest of Covered Persons to extend the term of the existing Agreement by one month.

NOW, **THEREFORE**, in consideration of the mutual covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and Conmed agree:

- 1. **RECITALS.** The Parties hereto incorporate the foregoing recitals as a material portion of this Amendment.
- 2. **AMENDMENT TO EXHIBIT A OF CONTRACT.** The Agreement shall be amended by deleting Section 2 of Exhibit A in its entirety and inserting the following language in lieu thereof:

Section 2 – Term of Contract

The term of this Contract shall be from August 1, 2016 to August 31, 2016.

- 3. **SEVERABILITY.** If any terms or provisions of this Amendment or the application thereof to any person or circumstance shall to any extent be invalid or unenforceable, the remainder of this Amendment or the application of such term or provision to person or circumstances other than those as to which it is held invalid or unenforceable shall not be affected thereby and each term and provision of this Amendment shall be valid and enforceable to the fullest extent permitted by law.
- 4. **DEFINITIONS.** Capitalized terms used but not defined herein shall have the meaning ascribed to them under the Agreement.
- 5. **REMAINING PROVISIONS.** The remaining provisions of the Agreement not amended by this Amendment shall remain in full force and effect.
