Contains U.S. and Georgia Constitutions. KAware (Knowledge Access Intl.) search software. Updated quarterly.
- ◇ *Georgia Cases* (West's) CD-Rom. West. Contains Georgia Supreme Court cases reported in West's *South Eastern Reporter* beginning with vol. 189, and Court of Appeals Cases in West's *South Eastern Reporter, 2d* beginning with vol. 33. Coverage is 1936-present for the Supreme Court, 1945-present for the Court of Appeals, 1977-present for Georgia Attorney General opinions, and Table of Cases. Premise search software. Regular disc updates and weekly advance sheets.
- ◇ *Georgia Law on CD-Rom*. Darby Printing Co. Complete text of the Georgia Supreme and Appeals Court Reports back to 1950, Advance Sheets through present, Code of Georgia as promulgated by the State Legislature, and Rules and forms of all the State courts.
