APRA request for Documents on Decertified Officers

Mr. Stecklow:

Please consider this letter in response to your Access to Public Records Act ("APRA") request, dated April 21, 2017, and received by me on the same date, regarding records maintained by the Indiana Law Enforcement Training Board/Indiana Law Enforcement Academy for decertified officers.

Your specific request was as follows:

"I request all information about all police officers that have ever been decertified by [the] Indiana Law Enforcement Academy (ILEA), including but not limited to the following:

- First, middle, and last names (middle initial is acceptable)
- ·Law enforcement agency
- •Date of appointment to that police agency
- ·Any other police agencies that the officer was certified with ILEA under
- ·Year of birth
- •Date of original certification by ILEA
- •Date(s) of any subsequent recertification(s) by ILEA
- Date of decertification by ILEA
- ·Reason for decertification"

As a matter of clarification, the Indiana Law Enforcement Academy (hereinafter referred to as "ILEA") is the training arm of the Indiana Law Enforcement Training Board (hereinafter referred to as the "LETB"). The development of standards for the training of police officers, the certification of police officers, and the decertification of police officers are the functions of the LETB; the conduct of the training to meet those standards and to nominate students for certification as police officers are duties of the ILEA.

After review, the LETB cannot grant your request at this time due to certain legal deficiencies. As required by APRA, a request for public records must be made with reasonable particularity. I.C. §5-14-3-3(a). Although 'reasonable particularity' is not defined by APRA, Indiana's Public Access Counselor ("PAC") has advised that a public records request should not contain language such as "any and all". PAC Advisory Opinion 16-FC-01 (2016). Therefore, your request does not meet this standard. Further, the PAC has also advised that APRA requests must specify dates. PAC Advisory Opinion 09-FC-24. Your request appears to request information, not documents.

To be clear, the ILEA is not denying your request; to the contrary, I merely request that it be amended to satisfy basic legal requirements.

Notwithstanding, your stated request does specify certain information regarding decertified officers. As the LETB has decertified only 38 police officers, I am able to identify a portion of the documents you request.

Upon receipt of your amended APRA request, the ILEA will begin to identify and gather all records that are responsive to your request. Under APRA, and other Indiana laws, ILEA must withhold records that are confidential, deliberative, contain test scores, etc. Also, some records may be redacted in order to be produced. Pursuant to I.C. §5-14-3-3, all disclosable records will be provided in a reasonable period of time. Should a denial to produce a record occur, ILEA will cite the specific provision that authorizes ILEA to exempt a specific record. I.C. §5-14-3-9.

Without waiving the foregoing, your stated request does specify certain information regarding decertified officers. As the LETB has decertified only 38 police officers, I am able to identify a portion of the documents you request. I have enclosed with this letter the "person record/training record" for each of the 38 decertified police officers. These documents contain information that appears to be responsive, at least in part, to the first six bullet point items contained in your request.

As to your request for records "in a format readable by a program such as Microsoft Excel or Google Sheets", in addition to the foregoing, I'm informed by our Senior Systems Analyst Jim Miner that Acadis is the program developed by Envisage to utilize the Oracle database program and your request will require Envisage to develop an 'ad hoc' program to excise out the information that is non-disclosable. The cost of this 'ad hoc' program will be dependent upon the specification of records you request. Once you have specified the records with particularity, as required by statute, I will relay the information through channels to Envisage, who will generate an estimate of the cost of the 'ad hoc' program. I will then forward that cost estimate to you for your consideration because, as you know, the direct costs incurred by ILEA/LETB to provide the information in the form you requested may be charged to you. I.C. §5-14-3-8(g)(1).

Regarding your request for "date(s) of any subsequent recertification(s) by ILEA", and at the risk of being presumptuous, I assume that you mean 'recertification' as a police officer. Many police officers are also instructors certified by ILEA, which require periodic recertification. However, a basic certificate as a police officer, bestowed by LETB, does not require 'recertification' per se, but Indiana law does require 24 hours of training annually, with a minimum of two hours in each of the following areas: firearms, defensive tactics, and emergency vehicle operations in order to maintain certification. Please refer to I.C. §5-2-9 and 250 IAC 2 for specifics on these requirements.

Finally, your request for "reason[s] for decertification" does not identify any documents whatsoever. The Acadis program does not contain any 'reason' for decertification, only the fact that an officer has been decertified (sometimes called "revoked"). Please provide information regarding particular documents to which you refer as being responsive to this request.




