

- CRESCENT CITY, CALIFORNIA
- TWO ENVELOPES RECEIVED
- ADDRESSED TO WARDEN AND MEXICAN MAFIA MEMBER

- WHITE POWDERY SUBSTANCE
 - TESTED POSITIVE FOR RICIN

RICIN DISCOVERY WITHIN INCOMING MAIL AT PELICAN BAY STATE PRISON



- ADMINISTRATION BUILDING, MAILROOM, AND WAREHOUSE THAT RECEIVES MAIL / PACKAGES EVACUATED
- 116 STAFF PLACED IN QUARANTINE IN A SECURED AREA
- 3 SUBSEQUENTLY HOSPITALIZED THEN RELEASED
- NO INJURIES REPORTED
- WORKING TO ENSURE NO FURTHER CONTAMINATION

MAIL HANDLING SAFETY PRECAUTIONS



- NITRILE GLOVES
- SAFETY GLASSES
- PROPERLY FITTED N-95 MASK
- DISPOSABLE PAPER SUIT OR COVERALLS
- SHOE COVERS
- NALOXONE INJECTORS

GENERAL SAFETY PRECAUTIONS



- MINIMIZE SKIN CONTACT WHEN RESPONDING TO A SITUATION WHERE SMALL AMOUNTS OF UNKNOWN SUBSTANCE IS VISIBLE AND MAY BECOME AIRBORNE
- DO NOT TOUCH YOUR EYES, MOUTH, NOSE OR ANY SKIN AFTER TOUCHING ANY POTENTIALLY CONTAMINATED SURFACE
- WASH YOUR HANDS THOROUGHLY AFTER HANDLING MAIL AND BEFORE EATING, DRINKING, SMOKING, OR USING THE RESTROOM
- WASH SKIN THOROUGHLY WITH COOL WATER AND SOAP
- DO NOT USE HOT OR WARM WATER
- DO NOT USE HAND SANITIZERS

GENERAL SAFETY PRECAUTIONS



- COORDINATE CLOSELY WITH FACILITY EMERGENCY PREPAREDNESS MANAGER AND FIRE – SAFETY SPECIALIST
- HAVE A NARCAN EMERGENCY RESPONSE KIT
- HAVE AN EMERGENCY RESPONSE PLAN
- REGULARLY TRAIN UPON YOUR PLAN

SECURITY THREAT GROUPS



K.A.R. 44-12-325c

- “SECURITY THREAT GROUP” SHALL MEAN ANY ONGOING FORMAL OR, INFORMAL ORGANIZATION, ASSOCIATION, OR GROUP OF THREE OR MORE PERSONS WITH A COMMON NAME OR IDENTIFYING SIGN OR SYMBOL, BUT WITHOUT SPECIFIC APPROVAL BY THE WARDEN.

SECURITY THREAT GROUPS



K.A.R. 44-12-325c

- OFFENDERS SHALL NOT DEVELOP, ORGANIZE, PROMOTE OR ASSIST ANY SECURITY THREAT GROUP, AND SHALL NOT ENGAGE IN ANY ACTIVITY CALCULATED TO INCITE A DEMONSTRATION BY ANY SECURITY THREAT GROUP.

SECURITY THREAT GROUPS



K.A.R. 44-12-325c

- OFFENDERS SHALL NOT POSSESS ANY ITEM WHETHER IN ITS ORIGINAL CONDITION OR IN AN ALTERED STATE ASSOCIATED OR IDENTIFIED WITH ANY SECURITY THREAT GROUP.

SECURITY THREAT GROUPS



- MORE APPROPRIATE TERM THAN "GANG"
- ENCOMPASSES MULTIPLE SECURITY THREATS
- ACKNOWLEDGES NOT ALL THREAT GROUPS HAVE CONNECTION TO CRIMINAL STREET GANGS
- ACCURATELY DESCRIBES IMPACT ON SECURITY AND INSTITUTIONAL OPERATIONS

GANG GENERIC VS. GANG SPECIFIC

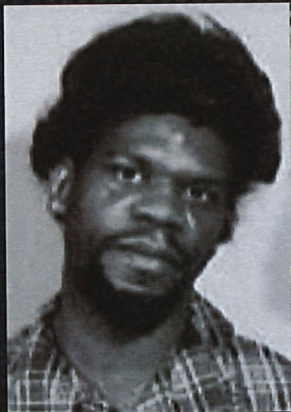
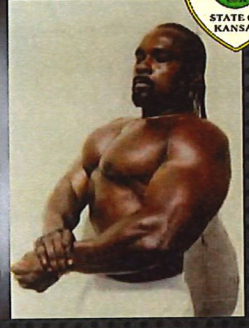
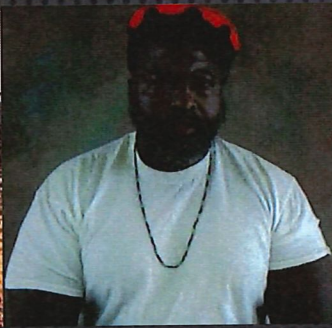


- RESPONSIBLE FOR THE IDENTIFICATION, VALIDATION, ANALYSIS AND TRACKING OF STG INFORMATION.

SUBSCRIBE TO SOVEREIGN CITIZEN IDEOLOGY THAT BELIEVES...

- THE GOVERNMENT HAS CREATED A "STRAW MAN" ACCOUNT TO STEAL THEIR RIGHTFUL WEALTH

SOVEREIGN CITIZENS



- USE LANGUAGE FROM THE UNIFORM COMMERCIAL CODE (UCC)
- LEGAL TERMINOLOGY THAT IS NONSENSICAL AND OUT OF CONTEXT
- WHEN PAPERWORK IS DISMISSED OR RESPONDED TO CONTRARY TO THE OFFENDER'S BELIEFS, INCREASES COMPLAINTS ABOUT GOVERNMENT CONSPIRACY TO VIOLATE HIS "NATURAL SOVEREIGN RIGHTS"

SOVEREIGN LANGUAGE



- “IN ADMIRALTY TACIT PROCURATION”
- “NOTICE OF FINAL DETERMINATION AND JUDGMENT IN NIHIL DICIT (LATIN FOR “HE SAYS NOTHING”)”
- “LIBELLANT” OR “LIBELANT”
- “NEGATIVE AVERMENT”
- “COPYRIGHT NOTICE AND SELF-EXECUTING AGREEMENT. THIS IS AN INTERNATIONAL NOTICE.”

SOVEREIGN LANGUAGE



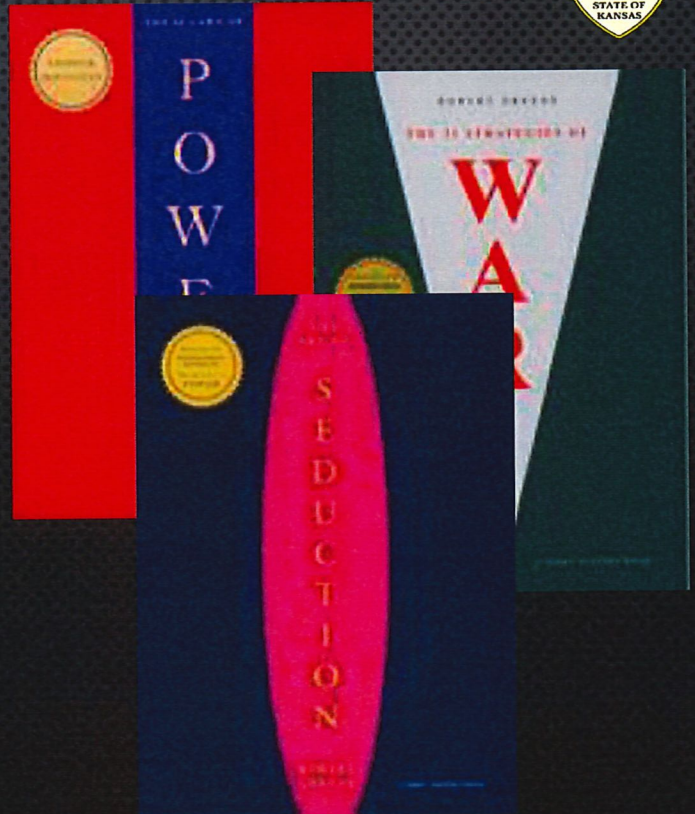
- *SUI JURIS* – LATIN FOR “OF ONE’S OWN LAWS”
- *SPC* – “SECURED PARTY CREDITOR”
- *UD* – “UNDER DURESS”
- *ERAL* – “EXPRESSLY RESERVING ALL LIBERTIES”
- *WITHOUT RECOURSE*
- *ALL RIGHTS RESERVED*
- *NATURAL PERSON*
- *FLESH AND BLOOD PERSON*
