The only guidance we received during my first deployment was that detainees at Kandahar Airport were to be advised of their U.S. Constitutional Rights (Miranda warnings) which I thought was absolutely ridiculous the team leader agreed with me, but the headquarters personnel and the two New York agents with us thought we should advise them of U.S. Constitutional Rights. When I out briefed Director Mueller he was unaware that we were advising detainees of "their" Miranda warnings. He said we should have been in on all interviews. The FBI was not a part of these critical interviews just after 9/11 because Military Intelligence did not want us advising someone and then they invoke and any time sensitive information they might have would be lost. 23.
