Summary of How the Death Occurred:

On 07/21/07 at approximately 0208 hrs the deceased was located as he was attempting to conceal himself in the bed of a pickup truck in a closed mechanic shop parking lot. When officers contacted the deceased they observed him to have signs and symptoms consistent with a person under the influence of drugs and/or alcohol. The officers attempted to arrest the deceased for public intoxication at which time an altercation esued between the officers and the deceased. The deceased kicked and struck the officers several times. The officers used several knee strikes to the deceased's torso to subdue him. The deceased was handcuffed and transported to the Pasadena City Jail where he was booked for assault on a police officer and resisting arrest. Due to the altercation at the scene the arresting officers summoned an ambulance to the jail. The deceased was evaluated by ambulance personnel who found the deceased's vital signs to be normal. The decased refused transport to the hospital and was confined in a holding cell in the booking area of the jail. At approximately 0740 hrs on 07/21/07, jail staff observed the deceased was not breathing and summonded an ambulance, who pronounced the deceased dead. An autopsy revealed that the decased had 11 rib fractures on 8 of his ribs. One of the rib fractures pierced the deceased lung which caused him to bleed internally. It should be noted that due to the decased's age, poor nutrition, and alcoholism, he was more susceptible to broken bones, including ribs.
