ON 7-29-04 I SPOKE TO INMATE BRANDON CLEARY 87062 IN THE PROGRAMS BUILDING AT CCCF ABOUT THE RIOT. HE SAID THAT THE FACILITY KNEW IT WAS COMING. THEY TRIED TO APPEASE THE WASHINGTON INMATES WITH MINTS AND CHEESEBURGERS. HE HEARD BEFORE THE RIOT THAT INMATE'S TOLD C/O BLANCO THEY WANTED TO SPEAK TO SOMEONE ABOUT SOME ISSUES.
