# B. SETTLEMENTS AND AWARDS:

Renee Clark v, United States of America, 1:97cv404-D-D (S.D> Miss.) This is the case where the female inmate was released 34 days late at TAL. She subsequently violated supervised release and was returned to custody. The 34 days were credited against her supervised release violator term.

# C. SIGNIFICANT CASES, TRIALS or HEARINGS:

1. Freson v. U.S. et al., 97-1373-CIV-GRAHAM (FFLS)
In this <u>Bivens/FTCA</u> case, a courier who was making a delivery to FCI Miami alleges that he became involved in a verbal altercation with a Lieutenant who assaulted him by hitting him with his fist, causing him to strike a flagpole with his face, break his glasses and sustain injury. The U.S. Attorney has taken a personal interest and is handling this case himself.

b2 The case is set for trial on November 3, 1998.

2. Blackwell v. Graham, 97-482-CIV-UNGARO-BENAGES (FFLS) In this <u>Bivens</u> case, an inmate alleges that he was assaulted by a case manager who struck him with a fist. The case manager did receive disciplinary action for Unprofessional Conduct, and documentation created at the time suggests this was because he had been found to have assaulted the inmate. However, the Warden who made the decision has submitted a declaration stating that it was really for Unprofessional Conduct based on language, not physical assault.

**b5** He

is not considered credible on this point because he has submitted conflicting statements at various times. Motion practice has not resulted in dismissal. The judge adopted an adverse report and recommendation on somewhat different grounds than the magistrate recommended, and found that a jury could find the plaintiff was attacked without provocation and that his injury was not de minimis. The case has been reported as ready for trial to the judge by the magistrate, but a trial date has not been set.

#### 2. Porto v. U.S.,

The inmate alleges medical malpractice as to treatment for his diabetes and an infection of his toe while at FCI Jesup, which led to amputation of his toe and ultimately his lower leg. There have been a number of depositions taken and a mediation meeting with opposing counsel. We still have a motion pending for dismissal on the basis of failure to file within the statutory limitations period. The case is set for trial on November 5, 1998. If this case goes to trial, it will be a battle of the experts.

# 4. <u>Viera v. U.S.</u>, 2-97-0499-12 (FSC)

The inmate alleges medical malpractice in that the BOP did not properly treat an injury he sustained to his achilles tendon. The tendon was sutured by an orthopedic surgeon and the sutures became infected. He was treated with antibiotics, but because of the infection he was transferred to an outside hospital and a cast was applied to his leg. His leg eventually healed with some scarring and he regained a full range of motion. He reinjured his leg while playing basketball at another institution.

treating orthopedic doctor is our expert witness.

A Regional Inquiry Team was dispatched to FCI Yazoo City to review the situation of an inmate who went on a hunger strike and was taken to an outside hospital shortly before his release date, where he remains in a comatose state. Van Vandivier was assigned as attorney-advisor to the team. Preliminary information is that the inmate was intent on causing himself to be in a poor state of health when he was released so the State of Mississippi would be unwilling to assume responsibility for his medical care and so would not prosecute him on pending charges. A final report from the inquiry team should be available in the near future.
