**Incident Details:**

On August 10, 2007, at approximately 2000, I responded to L-41, for a report of flooding on the top tier of L-41-A-Pod. Once I entered the pod, I could see water falling from both end cells of the top tier, cells #1 housing Longmire, Edward (1210645) and #7 housing Jackson, Michael (1244294). I then looked into these cells, and noticed both toilets flowing over. At this time, I retrieved the pipe chase key, to shut the water off to the affected cells. When I placed the key in the doors, I was unable to open them. Foreign objects had been placed in all pipe chase locks and council room locks, preventing the water from being shut off. I then notified Captain Scheffler, who arrived on post, and inspected the locks as well. At approximately 2011, a "Code Red" was called on L-41, and the Engineer was called in, to have the water shut off to the entire side of the building.

I then proceeded to the CERT room for gear, and briefing. Once the team was assembled, it consisted of the following members:

Sgt. C. Black- Team Leader  
Sgt. M. Moore- Pepper ball launcher & Alternate Team Leader  
Deputy L. Mehn- Shield  
Deputy W. Poole- Right Arm  
Deputy M. Jackson- Left Arm  
Deputy G. Huber- Right Leg  
Deputy W. Gaffney- Left Leg.

Deputy D. Pieranni- Video Recorder/ Later part of extraction team, when handed off to Deputy R. Feilhauer.

Once briefed of the situation, we responded to L-41, and arrived on post at approximately 2015. After reviewing the situation, we decided to move the prisoners, to L-22 one at a time, so they could be placed in cells with water shut off, to prevent any further flooding.

We then proceeded to cell #7 on the top tier, housing Jackson, Michael (1244294). Once at his door, he was asked, if he was going to comply, and cuff up. He began walking around his cell, and would not respond. While giving verbal commands for him to cuff up, I noticed his pass through door would not open, and that he had sheets and wet newspaper stuffed under his

Door. We also could not open his cell door manually or from the touch screen. We then moved on to cell#5, housing Croft, Damon (1246756), who cuffed up immediately, and was taken out of the pod. Next, we went to cell#1, housing Longmire, Edward (1210645). Verbal commands were given to him to cuff up, to which he complied, and was also taken out of the pod.

Once all of the top tier were cleared out, except Jackson, and placed on L-22, we proceeded to the bottom tier, starting with cell #2, housing Patton, Jonathan (1210041). Once in front of his, we inspected his locks, and noticed they were stuffed with foreign objects, wet newspaper and sheets were stuffed under the door, and books were jammed in the doorjamb. I then asked if he was going to comply, and he said "No". I then introduced a chemical agent into his cell, from the MK9 fogger, and began giving verbal commands for him to remove the books from the door. All commands were ignored, and Sgt. Moore placed (4) rounds of pepperball into his cell for saturation. Captain Scheffler, then stepped up to the door with the less lethal shotgun, and gave warning of its use, if he would not remove the books from the door. Again no compliance was gained. It was then decided, to move on to another cell, and come back.  
The team then moved to cell#4, housing Rutherford, Kenneth (1215655). \*Note\* His cell door was also in the same condition, as the previous cell. Rutherford began yelling "Your all going to have to shoot and kill me". I then introduced a chemical agent into his cell, from the MK9 fogger, and gave verbal commands for him to cuff up. All commands were ignored, and his pass through was forced open. Sgt. Moore then deployed (4) rounds into the cell for saturation. Rutherford, then dove under his bed, and would not come to the door. After more verbal commands were given for him to cuff up, he came to the door, but would not place his hands through the door. Captain Scheffler,




 up with the less lethal shotgun, and gave warning of its use, if he did not comply with orders, and put his hands out to be cuffed. He still would not comply, and stingball was deployed at Rutherford for pain compliance. Once deployed, more commands were given, to cuff up, and he placed his hands out. We were still unable to open his door, due to objects jammed in the hinges, so Rutherford was flex cuffed to his door handle, while the team moved on.  
 Next, the team came to cell #6, housing Nelson, Darnell (1227992). \*Note\* His cell door was in the same condition as the previous cell. He was standing at his door, with his face wrapped in a towel, and was holding his mattress against his door. He as well, would not comply with verbal commands to remove the objects from his door, and cuff up. Captain Scheffler then introduced a chemical agent, from the MK9 fogger, into his cell, while I gave commands for him to cuff up. Again, there was no compliance, so another application of the MK9 fogger was given. Nelson then agreed to remove the objects from his door, and the team was able to make entry. He was immediately taken down, cuffed, shackled, and placed in the restraint chair. Once in the sallyport, cell #8 housing Steffen, David (1261146), was evacuated from his cell, and taken to L-22.  
 Once the team was back in the unit, we proceeded back to cell #2, housing Patton (1210041). He was still refusing to cuff up, so his passthrough was forced open, and Captain Scheffler introduced a chemical agent, from the MK9 fogger, onto Patton's body, for irritation. He then agreed to be cuffed, and removed the books from his doorjamb. The cell door was then forced open, and he was cuffed, shackled, and carried to a cell on L-22.  
 While the team was on L-22, Captain Scheffler, and myself removed the flex cuffs from Rutherford's hands, to prevent his circulation from being cut off. Once we removed the flex cuffs, his door popped open, and

I drew the Taser on him, while Sgt. Buchanan, drew the shotgun. He was then instructed to get on his knees, and crawl to the restraint chair, or he would be shot. He then crawled to the restraint chair, and was restrained without further incident. At approximately 2134, Deputy Director Conley instructed Captain Scheffler, to have me leave, and find new cells for all of the prisoners, away from each other. I then handed my gear over to Sgt. Buchanan.

While looking for cells, the team proceeded on to cell #7, housing Jackson (1244294). He still refused to comply with orders, and Sgt. Buchanan deployed (4) rounds of PepperBall into his cell. More commands were given, to cuff up, but no compliance was gained. Sgt. Buchanan then introduced a chemical agent into the cell, from the MK9 fogger. His cell door was then forced open. He was cuffed, shackled, and placed in the restraint chair. While in the chair, Jackson became combative, so, Sgt. Moore deployed (3) rounds of pepperball to Jackson's center mass. He was then secured and taken to L-22.

Once all inmates were on L-22, they were checked by Nurse Sharon King, and placed into the showers for decontamination. They were then given clean uniforms, and taken to their new locations. The team stood down, and the "Code Red" was disregarded at 2221.

\*Note\* the pipechase and pass through doors, were functional, before Longmire (1210645) had his hour out, and a shank was recovered from his cell.

Per. Medical, all inmates involved are ok, for DBU's.


