Synopsis:

On 02/24/2006, Washington Corrections Center for Women (WCCW) Chief Investigator Kelly Kelly contacted the Department of Corrections (DOC) Special Investigations Unit (SIU) and stated that an offender housed at WCCW had alleged that a Correctional Officer (C/O) at the facility had sexually assaulted her (ATTACHMENT A). The offender, the stated that C/O Johnnie Davis had given her little gifts like candy bars, apples, barbeque ribs and cheese burgers; made photocopies of her court paperwork for her and taken her into a storage closet, covered the window and kissed her; sucked on her breast and fondled her vagina. Offender stated that the incidents occurred in the Close Custody Unit (CCU).

Due to the nature of the allegations, DOC SIU initiated an investigation.

Investigator Tim Thrasher interviewed offender at WCCW in the SMU; Investigator Steve Baxter was also present. Investigator Thrasher explained to offender that she was being interviewed due to the allegations she had made regarding C/O Davis. Investigator Thrasher stressed to offender that it was important for her to be truthful. Offender that agreed to be interviewed.

Note: During the interview of offender she did not transition from event to event in chronological order. The following summary of the interview that occurred is documented in the order that she described events.

Investigator Thrasher asked offender to explain the series of events that led up to C/O Davis touching her in a sexual manner in the storage closet. Offender in June of 2005, she was working in the laundry area. C/O Davis was her supervisor while she was working. Offender stated she always lives on the first tier because she has a HSR and cannot climb stairs very well. During the time that C/O Davis was her supervisor, he was always nice to her. Offender stated she even admitted to him that she considered herself to be a lesbian. Offender stated in August of 2005 her brother died and C/O Davis was very supportive towards her. Offender felt like he was trying to become friends with her. C/O Davis told her that he had lost a family member and knew how she felt. Offender stated C/O Davis began to give her large amounts of extra duty and during these times, he would give her king size candy bar, large bags of M&M's and other types of candy. Offender added that C/O Davis made unauthorized copies of her legal work for her on a few occasions when she asked him to.

Offender was tated C/O Davis gave her three fifty dollar bills on one occasion in November 2005. Offender gave the money to her cellmate, offender who in turn took it to the visiting room during a visit with her mother. Offender stated offender mother took the money and she did not get anything out of it. Offender stated the plan she devised with offender was

to have her mother buy her a coat and send it into the institution with the money. Offender stated she was very upset that she got "burned" in the deal. stated C/O Davis gave her a note one day that was on a pharmaceutical post it note. The note had some pictures of camera flashes and said "I love you. Cameras are everywhere. I want you. Not married. Raise my grandson." Offender after she read the note she flushed it down the toilet and C/O Davis was standing nearby. Offender stated the note "creeped her out." Offender stated on 09/26/2005, C/O Davis gave her the book "Have You Felt Like Giving Up Lately" written by David Wilkerson (Attachment B). Offender stated she felt like C/O Davis cared about her after receiving the book she added that she had also received candy and gotten paid for work that she had not done. Offender stated on 10/26/2005 C/O Davis took her to get cleaning gear in the unit storage closet. When she removed the cleaning items, C/O Davis told her to put them back because she was not going to be working. Offender stated that she walked into the storage closet with C/O Davis and he closed the door. The windows had paper covering them and C/O Davis began to kiss her. C/O Davis sucked on her left breast and played with her vagina through her clothing. Offender stated C/O Davis began to suck her nipple "too hard" and play with her vagina. Offender stated she pulled away from him because "it didn't feel good." Offender stated C/O Davis never penetrated any part of her body. After she pulled away from C/O Davis, it was time for recall and she went back to her cell. stated a short time later (a few days), C/O Davis took her to the storage closet again. C/O Davis kissed her while she was cleaning the bathroom and told her "I love you. The rest of my life I'm yours." Offender I stated she was not interested in his advances anymore. stated when she got out of the SMU for strong-arming in November, Offender she realized that C/O Davis was not working in his position anymore. She found out he was working in the "TEC" building, so she went there to confront him. Offender stated C/O Davis was nervous during their discussion and he said "Your secrets safe with me, I won't tell anyone." Offender stated recently during the time that she was housed in the SMU, C/O Davis would call her on the intercom and try and talk to her. Offender added that his would also stand at her door and try and talk to her. Offender behavior "creeped her out." Investigator Thrasher asked offender why she didn't tell staff what had happened before now. Offender stated that at first she didn't mind the attention but as it got more serious she began to fear retaliation from staff if she told. stated she was sure she did not talk about everything that occurred between her and C/O but, requested that the notes she had taken regarding C/O Davis be copied. (Attachment C) Additionally, during the interview offender stated numerous times that she wanted to participate in a polygraph examination.

Investigator Thrasher interviewed offender at WCCW in an interview room regarding another unrelated incident that involved offender Investigator Baxter was also present. Investigator Thrasher explained to offender why she was being interviewed and she agreed to participate. During the interview, offender mentioned C/O Davis and conversations that she had with offender regarding him. Offender stated offender asked her to support claims she was going to make against C/O Davis, because she was going to make \$50,000.00 and get transferred to Hawaii "one way or another." Offender that offender told her that the transfer to Hawaii had not been completed correctly by her counselor. Offender stated offender had bragged to her about having sex with C/O Davis while she was a graveyard janitor. She added that offender lso mentioned that he had given her a book, a greeting card and numerous food items. Investigator Thrasher asked offender if she ever witnessed C/O Davis do anything inappropriate while he was around offender Offender Tobeck stated she never witnessed C/O Davis do anything inappropriate. Investigator Thrasher asked offender if C/O Davis ever talked to offender over the speaker system in stated she never their cell during the time that they were cellmates. Offender heard C/O Davis talking to offender Investigator Thrasher asked offender f she ever saw offender eat food or candy that was not available through institutional channels like "King Size" candy bars or other items. Offender she had not witnessed offender atting any unauthorized food items. Offender stated offender made it known to her that she was going to make serious allegation against C/O Davis and get paid by the state. Offender ended the conversation by saying that offender told her she had made the story up and wanted to make money off of a lawsuit like some of the other offenders in the facility had done in the past.

Investigator Baxter asked offender if offender had ever given her any money to smuggle out through the visitation room with the assistance of her mother. Offender stated that she declined to assist offender in any of her "scams."

Investigator Baxter interviewed C/O Davis on 04/07/2006 in the WCCW Training Room. Investigator Baxter explained to C/O Davis that an offender made allegations of a sexual nature against him. C/O Davis agreed to participate in the interview process; Union Representative Sgt. Michael Delgado was also present. Investigator Baxter asked C/O Davis what he knew about offender I stated he knew offender because she had been a janitor in the Close Custody Unit (CCU) where he worked on occasion. Investigator Baxter asked C/O Davis if he had ever any contraband such as food or notes. C/O Davis stated that he given offender had never given offender inything that would be considered contraband. Investigator Baxter asked C/O Davis if he had ever given offender any gift cards or books and showed him a copy of the book, "Have You Felt Like Giving Up Lately". C/O Davis denied that he had given anything to offender including gift cards and the book. Investigator Baxter asked C/O Davis if he had ever touched offender in a sexual physical manner in any part of the facility. C/O Davis stated he had never . Investigator Baxter asked C/O Davis if he sexually / physically touched offender had ever physically had contact with offender in the SMU or TEC unit. C/O Davis stated he would have physically touched offender leaves the same as any other offender in the unit, due to a heightened security level. Investigator Baxter asked C/O Davis if he had ever made paperwork copies for offender at WCCW. C/O Davis stated he never made paperwork copies for offender . C/O Davis reiterated that he did not have a relationship with or do anything inappropriate with offender

Polygraph Notes:

On 03/20/2006, William Tufts / GSR Polygraph Services attempted to administer a polygraph to offender regarding the allegations she made against C/O Davis. Tufts determined that offender could not be polygraphed "due to the subject being emotionally upset and crying". (Attachment E)

On 03/30/2006, Rick Minnich / Minnich Polygraph Service administered a polygraph to offender egarding the allegations she had made against C/O Davis. The following questions were asked:


1. Did you lie when you stated that Corrections Officer Davis sucked on your breast?

2. Did you lie when you stated that Corrections Officer Davis fondled your bare vagina?
Offender answered both questions "No." When Minnich reviewed and scored the polygraph charts, he determined that offender was being deceptive when she answered both questions. (Attachment F)

Summary:
Based upon the information received and individuals interviewed, there is no information available to substantiate any of the allegations offender as made against Correctional Officer Johnnie Davis. In her complaint, offender alleged that C/O Davis kissed her, sucked her breast, fondled her vagina, gave her contraband on several occasions (book, card, notes, food items), made copies of her legal work and attempted to engage in a personal relationship with her. Although offender supplied a book and greeting card that C/O Davis allegedly gave to her, there is nothing available to identify the origin of the items. Offenders that were interviewed at WCCW stated that offender talked openly with them about getting a large amount of money from the state by making allegations against a staff marrher. Additionally, offender to participated in a polygraph on

Dear Mr. Thrasher:

As requested by a conducted a specific polygraph examination. The purpose of this examination was to determine whether Corrections Officer Davis sexually assaulted her between October and November 2005. The following information was provided to me by your client.

INFORMATION

Ms reported on Febryary 14, 2006, she reported to her counselor at WCCW that Correctional Officer Jonnie Davis had sexually assaulted her on two occasions. Ms. tated the first assault occurred on October 26, 2005, in a closet next to the staff bathroom in the Closed Custody Unit. She said the officer kissed her, suckled her left breast, reached down her pants and fondled her bare vagina.

Ms experience eported the second assault occurred two weeks subsequent to the first in the staff bathroom. She said when she was cleaning the bathroom, Officer Davis stood in the doorway and kissed her. She denied he engaged her in any other hands-on sexual assault.

However, Ms. hen stated between August 2005 and December 2005 Officer Davis told her he "loved her" and gave her items to include candy, food, money and a book.

INSTRUMENTATION

The questions to be asked during the instrumentation portion of the polygraph examination were constructed and reviewed with Each relevant question was a subject of discussion to insure a common meaning.

I then proceeded to test whether Ms. alsified or withheld information pertaining to this interview. This was accomplished by conducting a Bi-Zone Comparison Test. This test consisted of the following two relevant questions, to both of which she responded "NO":

- 1) Did you lie when you stated that Corrections Officer Davis sucked on your breast?
- 2) Did you lie when you stated that Corrections Officer Davis fondled your bare vagina?

RESULTS

After scoring the polygraph charts, it was my opinion the physiological responses indicated Ms. did not answer truthfully to the questions. **DECEPTION WAS INDICATED.**

POST-TEST

During the post-test interview, Ms. examination because when the questions regarding Officer Davis were asked, she recalled Officer Davis "sucked really hard" on her breast during the assault. She was either unwilling and/or unable to offer any other reason for her deceptive responses.


