Offender a stated that she had been in a romantic relationship with CO Gordon for over two years while at WCCW. Offender stated that this relationship began in the chapel in 2001. This relationship was physical with them kissing in the gym, school and chapel. The relationship was volatile with them fighting quite often usually in the school. Offender stated that CO Gordon also brought her gifts like a pewter angel. 


