He proceeded to go into the property room ~~at least~~ in East Pod. He called me over to east property room and asked me to lift a box in there. So I went in and he was standing a little behind the door. When I walked in He shut the door. I stood in front of the door and dropped my pants. But first he took his radio off and put it on a shelf. Took his little belt thing off and took his pants off.

I stared at him for a minute and asked what he was doing. He said I could have the rest of the night out and he would help me with a package, drugs, whatever I wanted. He came up to me and pulled my grey shorts down and turned me around to face

in the corner. He then grabbed
my arse and tattoos. He then grabbed
round my stomach and entered inside
me. After about 2 minutes he said
I havent had any in a long time, please
excuse me. I told him I wanted out!
He told me to wait until he could put

couldn't see. He turned the light off
and said if I close the door behind
me dont come out. He left it open
so I came out! He told me to go
take a shower! I wiped myself off
with a towel in case no-one would

then sat in there for about 10 minutes
-rying. Right before count he came
up and asked "Have I been had"
Are you going to tell. I promised

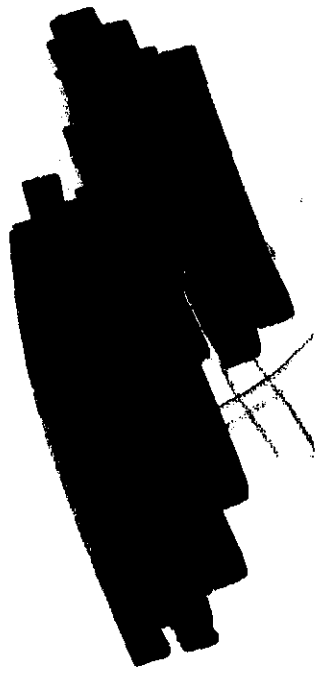

To whom it may concern:

This is in regards to the incident occurring on Tuesday the 26th in CCU, between inmate [REDACTED] and officer Mikelson.

It all started around 3:20 pm, I was out in the dayroom doing sanctions, as I had been since 11:00 that morning, when officer Mikelson approached me regarding my sanctions. He then told me he was having a bad day & sat down at the last table in the dayroom. His statement, of course, piqued my curiosity, so I asked him why he was having a bad day. He then proceeded to tell me that he might be getting walked off due to an incident on the hill. he said Kites had been dropped accusing him of having sex with inmates and he continued on, saying if he was being accused, he might as well do it and enjoy it. He also said his children have started to call him a dirty old man & he was beginning to believe them. Officer Mikelson then served me a [REDACTED]

question, asking me if an officer wanted to proposition an inmate, how would they go about it? I informed him that I'd never been involved with anything of the sorts, and I wouldn't have the faintest clue on how to do that.

It soon became 3:30, and a few inmates yelled to him reminding him of mail call, so he realized what time it was & excused himself to go get the mail. I then went directly up to inmate

[REDACTED] and informed her of the weird conversation that had just taken place. I was freaking out, and unsure of how I was to handle the situation. I think it bothered me more than it may off affected someone else, due to the fact I was sexually assaulted by "authority figures" in my younger days, and of course the scars still remain.

We then gathered around for mail call. After it was finished & yo Mikelson grabbed the "04021 box" as he left to put it in the conference room. He beckoned

me over by my last name. I went over to him and he said in a firm tone "Now you make it happen", and he walked out the door. By this time it was no recall so we all celled up. We were counted as usual, but as soon as they (the officers) were done counting, Mr. Mikelson came to my door and again said "Make it happen". By this time, I was pretty upset, although from years of prior experience, I've learned not to let it show. I then started to get ready for dinner and put my make up on, when I felt someone staring at me, so I looked at my door and sure enough there he was, just looking at me saying nothing. When he saw me look at him, he smiled at me and waved his hand at me directing me to come to my door, & so I did. He then put his face towards the crack of my door and said "I hope this don't offend you, but I want to jump your bones" - then he walked away. Soon after this incident...

and we were called to dinner. I met up with [redacted] & told her we needed to talk. At dinner time, me, her & [redacted] [redacted] and [redacted] all sat together. I then began to tell [redacted] of what had occurred during court time (I said it in a way that [redacted] & [redacted] would not know who or what we were talking about). It was at this point that [redacted] said "oh, Mr Mikelson did the same thing to me" and I then questioned her on how she knew it was Mr Mikelson and she said she knew because he had been coming on to her as well, and to confirm that he had, she told me what he had said about getting walked off, verbatim. We all then began to engage in conversation regarding other incidences regarding inappropriate advances made by other correctional officers. We briefly touched on the subject on if anyone would do it, or not but it was time to go before the conversation got grounded. W0404 [redacted] (myself) then [redacted] I was here

that we had discussed the situation in detail. [REDACTED] stated since she had nothing that she would do it in exchange for a package (clothing) as well as money put on her books. She said that she would keep something as "evidence" (she mentioned a towel or O-tips") and if he didn't pay, she would file charges against you. Now mind you, this is not her first time at this (she previously had sex with officer Nye at Spokaneish county jail) And at least 3 people in OCU alone, have claims pending against officers and sexual misconduct [REDACTED] as well as [REDACTED] and all of them receiving 7-8 digit figures, so this must have seemed like a perfect opportunity for someone with nothing trying to come up, especially someone who sells themselves for money/drugs. MS [REDACTED] also made the comment if she were to get pregnant, not only would she get money but she'd be released from prison. Our gym time is limited to 55 minutes a day.

talked with [REDACTED] & [REDACTED] for roughly 20 minutes, then went by myself to the weight pile & worked out & chatted with my friend [REDACTED].

(Our conversation had nothing at all to do with the incident). It was now first movement & time to return to CCU, on our walk there, [REDACTED]

said she was going to do it and my only reply was "good, get him away from my door".

When we got back to the unit, it was my hour out, so I went out to the leisure yard where I sat and spoke with

[REDACTED] (again, nothing to do with the incident). Half way through my hour out, [REDACTED]

approached me and asked me to please go tell %o Mikelson she was ready & I told her I didn't want to be involved in any way, her deal is her deal - she's a grown adult and I'm just trying to do my own time.

When our hour was out, I went inside, only to find %o Mikelson & Ms [REDACTED] sitting at a table #406 talking - I sat at the opposite [REDACTED] in the table and heard

% Mikelson, what he wanted me to do for sanctions. He told me to sweep, and he looked at [REDACTED] and asked her what she wanted - She giggled & said she wanted whatever he wanted & she smiled at him. I then jokingly told her to stop flirting and % Mikelson said she could flirt all she wanted. He then said he'd show her what he wanted her to do & he got up by himself & went to the "contraband" closet. Ms. [REDACTED] shortly followed and she stood at the door of the closet and talked to him for a good 2 minutes. She then went to go inside, but saw someone was looking & stepped out & began to act as if she was just talking to him by the door. I then saw her slip inside the closet & shut the door. I continued sweeping and around 5 minutes later the door opened & out came % Mikelson with his face beet red & out of breath, directly behind him came Ms. [REDACTED] % Mikelson directly went out to

the foyer, while Ms [REDACTED] walked up to the table closest to the laundry room, where four people were sitting and asked them what they were looking at, realizing that everyone in the unit witnessed what had just happened. [REDACTED]

& myself had [REDACTED] come in the first tier janitor closet & asked what had happened. She stated they had had sex & that she had "grinded her butt up against him & he had ^{swim} inside her" - she then proceeded to say he had told her "She was the best fuck ever". When asked how it all went down, she said she went in the closet & pulled down her pants & panties & bent over & told him to look at her tattoo on her lower back, upper butt area, & it all happened from there.

By this time, the ENTIRE unit was talking about it, and [REDACTED] was freaked out, she said she knew someone was going to tell on her so she needed to tell first. Ms [REDACTED] then went up to go Mikelson & told him that

everybody know and if he were ever questioned about it, to say that she was just helping him move boxes.

Ms. [REDACTED] then approached me & said she had no clean clothes and asked if she could please borrow some shorts cause it was extremely hot, so I got her my shorts & she proceeded upstairs to the 2nd tier where she lives. I then went to % Mikelson & had to sit & wait 10-15 minutes while he helped another inmate, before I could get him to sign off on my sanction hours for the night. It was then recall a time for evening count, so I went to my room (on the 1st tier). After count time % Mikelson came to my door and told me people were saying he'd been set up and I needed to keep what I knew to myself or there would be consequences & repercussions - and so I did just that.

The following morning when I woke up, there was "Do NOT ENTER" tape around the [REDACTED] 0409

was no where to be found.

After breakfast, I came back & again continued to do sanctions.

After thinking about the situation, I tried to muster up enough courage to talk & tell what I knew. I told C/O Beaucraft that I needed to talk to Kelly Kelly, so he informed our booth officer (C/O Nordbye) & she supposedly left a msg. I then wrote a Kite & asked to speak to the Sgt. to which I was denied.

At 1:00, I finished sanctions & went to shower & get ready for school (cosmetology) at 2. I never quite made it. As

soon as I get out of the shower, I was handcuffed & taken to

Segregation. Upon my arrival here, Kelly Kelly & a Pierce

County detective came to question me. I once again became

scared, it was a deja vu of my prior experience with

being raped. I was scared to tell the truth, for fear of

retaliation etc. During the interview, I was asked why A410

Ms [redacted] would have it out for me, and I can name numerous

reasons. She was

my "girlfriend" for 6 months, until I realized I wasn't gay, just curious. For the last year she's been chasing me around, trying to get back together with me. In fact just a couple months ago, she tattooed my name down her leg in big letters as a symbol of her love for me. I also have numerous love letters & poems in my property from her, declaring her undying love for me and even calling me "her wife". About 2 weeks prior to this, we were both in the hole & she was continually saying how she loved me & would do anything to get me back, and I have many witnesses who will substantiate my claim. This is the only reason I can see for someone to be so mean & vindictive & lie on me. I also find it pretty convenient that [redacted] & [redacted] have been best friends since the age of 11, hence they stick together. It is also pretty convenient that they are both on the same

able to conjour up a "story" accordingly. In fact, Ms [REDACTED] has made it known to every-
one in the hole, that she is writing statements to get [REDACTED] out, but has every intention of making sure I take the blame.

Ms [REDACTED] has also made it known her attorney for this is Monty Hester, and that she's looking at 100 thousand dollars and her \$ [REDACTED] are going to split the money and she'll "see who's laughing now". I think that this is unfair. I realize I don't have the perfect track record, but I learned my lesson last time. I want to do right for me & my children and the only important thing to me is their visits, which I'm missing out on due to this. All I ask if for you to please administer a lie detector test, to find the truth once & for all. I appreciate your time & attention regarding this matter.

Subjective

Ms. [redacted] came to my office. She explained that her cellmate had come to the cell and began talking about [redacted] and [redacted]. They had a plan to entice an officer into having sex then to blackmail him in order to force him to bring items into the institution. Ms. [redacted] said that she advised her cell mate not to get involved but later in the evening, after med-line and mail call, her cellmate came back to the cell flushed. She heard another offender say "did you just see what I saw?" Ms. [redacted] said that her cellmate was tearful after the encounter and she admitted to just having sex with an officer. Ms. [redacted] advised her cellmate to wipe herself with a towel and swab. At that point [redacted] came in and sat in the cell with Ms. [redacted] and her cellmate. She said "oh my God I didn't think you'd really do it." After that encounter she advised her cellmate to reveal the sex act to authorities. Ms. [redacted] advised that she felt very guilty at being the one to bring this to light. Ms. [redacted] believed that her cellmate was vulnerable to suggestion by the other offenders because she was slow and that she had a need to be accepted. She felt protective of her cellmate who she believed was in SEG and for the officer who she described as a "nice guy."

Objective

Ms. [redacted]'s hair was well cared for and her hygiene appeared good. Her clothes were clean. Her gait was steady. Her posture was neither rigid nor slumped. She did not gesture and no restlessness was observed. Her facial expression was appropriately animated and she smiled (and cried) at suitable times. Her speech was at a normal cadence but her voice was soft. Eye contact was good.

Ms. [redacted]'s affect was dysphoric. She was oriented to person, place, time and circumstance. Her demeanor did not seem glib. Some anxiety was evident. Anhedonia was not evident. There was evidence that her thinking was tangential. Her attention span was functional. Her frustration tolerance seemed efficient. Ideas of reference were not expressed. She was not overly submissive but neither was she controlling, domineering, provocative or overly suspicious. No grandiosity was evident. There was no obvious associational disturbance. No delusions, obsessions or phobias were noticed. No current objective signs of suicidal or homicidal ideation were evident.

Assessment

Ms. [redacted] is experiencing mild critical incident stress.

Plan

Advise her psychotherapist, Dr. Varick.
