Synopsis:

On 03/14/2006, Department of Corrections (DOC) Headquarters (HQ) Special Investigations Unit (SIU) Investigators Tim Thrasher and Steve Baxter interviewed offender [REDACTED] in the Snohomish County Jail regarding a separate allegation that she was involved in a relationship with a DOC employee. During the interview offender [REDACTED] stated that her current girlfriend, [REDACTED], was involved in a romantic/sexual relationship with a current WCCW Correctional Officer (C/O) in approximately 1998. Offender [REDACTED] stated that offender [REDACTED] and Correctional Officer Deborah Roan were involved in a relationship and she was worried that she would have problems when she returned to WCCW because C/O Roan knew they were currently together in a relationship. When asked what kind of problems she anticipated offender [REDACTED] stated C/O Roan has had sex with her current girlfriend on numerous occasions and if she tried to strip search her there would be problems. Due to the allegations the HQ SIU initiated an investigation.

Offender [REDACTED] was interviewed on 04/06/2006 at 9:45 AM at MCCC; Investigator Thrasher and Investigator Baxter were present. Investigator Thrasher told offender [REDACTED] she was being interviewed due to allegations that she was involved in a romantic/sexual relationship with a staff member at WCCW. Offender [REDACTED] agreed to participate in the interview.

Investigator Thrasher asked offender [REDACTED] if she had been involved in a relationship with any DOC staff members in the past. Offender [REDACTED] stated that she had been involved with two Correctional Officers in the past, Deborah Roan and Janice Jones. Offender [REDACTED] stated the relationships occurred several years ago and both were sexual. Offender [REDACTED] added that Janice Jones no longer works for DOC. Investigator Thrasher asked offender [REDACTED] how the relationship began between her and C/O Roan. Offender [REDACTED] stated C/O Roan approached her one day in early 1998 while she was cleaning her cell. C/O Roan knew she was getting out soon and asked her for her phone number. Offender [REDACTED] stated she was somewhat interested so she gave her number to C/O Roan and they started to talk often at WCCW before she was released. Offender [REDACTED] stated she was released from WCCW on 05/08/1998 and shortly after that C/O Roan called her at her residence in Redmond, WA. C/O Roan said she wanted to meet offender [REDACTED] and they met at Denny's in Tacoma on 6th Avenue. During the time that they met, they talked about general things and had coffee. A few days after meeting C/O Roan at Denny's, offender [REDACTED] stated she met C/O Roan at Janice Jones' (former C/O) house. Offender [REDACTED] stated C/O Roan was attracted to her and she knew they were going to be intimate with each other eventually. Offender [REDACTED] stated they usually had sex with each other in hotel rooms, the first occurrence was in a hotel room in Fife, WA. (Offender Roan identified a picture of Kings Motor Inn in Fife, WA as being the first location they engaged in sexual intercourse.) Offender [REDACTED] stated on another occasion, C/O Roan went out of state to a family member's funeral and when she returned, offender [REDACTED] picked her up at the airport and they stayed in a hotel on Highway 99. Several pictures of hotels in the location described were presented

to offender [REDACTED], she was unable to identify the hotel. Offender [REDACTED] stated that she had sexual intercourse with C/O Roan numerous times. When offender [REDACTED] was asked how many times she replied, "too many to count."

Offender [REDACTED] stated she was around C/O Roan's son on several occasions during that time he was three or four years old. On a few occasions, C/O Roan went to offender [REDACTED] daughter, [REDACTED] soccer games.

Offender [REDACTED] stated she broke off the relationship with C/O Roan in late 1998 and started dating Janice Jones. This relationship did not last long and eventually C/O Roan and Jones started dating. Offender [REDACTED] stated Jones is a very abusive individual that has assaulted her several times, including giving her black eyes and shooting at her twice. Offender [REDACTED] stated that most of the assaults occurred after C/O Roan and Jones started dating and were motivated by jealousy. Offender [REDACTED] stated C/O Roan and Marcia Jones, her current partner, had a triple wide in Tacoma, but did not own the property that it was on so they bought a house.

Offender [REDACTED] stated when she returned to WCCW in 2002, C/O Roan would give her daughter [REDACTED] a hard time about her clothing in the visiting room on a regular basis. Offender [REDACTED] stated C/O Roan's attitude towards [REDACTED] seemed to be vindictive since their relationship ended badly. C/O Roan would tell [REDACTED] that her clothes were too tight or she was showing too much skin. Offender [REDACTED] stated that [REDACTED] clothing was no worse than other visitors, but she didn't make a complaint because she feared she would be retaliated against.

Investigator Thrasher asked offender [REDACTED] if C/O Roan has approached her at any time about their relationship when she returned to WCCW. Offender [REDACTED] stated when she returned to WCCW on her current charge, C/O Roan approached her and said she had been questioned about their relationship and "they knew about everything." Offender [REDACTED] added that C/O Roan told her not to talk about anything regarding their relationship at WCCW.

Phone Interview

[REDACTED] was interviewed on the phone on 05/30/2006 by Investigator Thrasher. Investigator Thrasher explained to [REDACTED] why she was being interviewed and she agreed to participate. Investigator Thrasher asked [REDACTED] if she knew about any DOC staff that her mother, [REDACTED], may have had a relationship with in the past. [REDACTED] stated that when she was younger, approximately 15, her mother had a relationship with C/O Roan from WCCW. [REDACTED] stated that she met C/O Roan at one of her soccer games, because C/O Roan would come to the games occasionally.

[REDACTED] stated when C/O Roan came to the games she had a young boy with her, and she always assumed it was her son. [REDACTED] stated that she was young at the time and did not know for sure that her mother was gay.

[REDACTED] stated in approximately 2002 when her mother went back to prison, she would visit her at WCCW regularly. C/O Roan worked in the visiting room and would constantly harass her about the way she was dressed and how much skin she had showing. [REDACTED] stated she did not tell anyone because she did not want her mother to be retaliated against, and also didn't believe anyone would believe a teenage over a C/O at the facility.

Investigator Thrasher asked [REDACTED] if she saw C/O Roan anywhere else besides her soccer games and in the WCCW visiting room. [REDACTED] stated that she had not seen C/O Roan anywhere else.

[REDACTED] DOB: [REDACTED] 1971 Washington Corrections Center for Women (WCCW) 05/31/2006 10:30 AM

On 05/25/2006, Investigator Thrasher received information that offender [REDACTED] was involved in a romantic/sexual relationship with C/O Roan several years prior.

Offender [REDACTED] was interviewed at WCCW on 05/31/2006; Investigators Thrasher and Baxter were present. Investigator Thrasher told offender [REDACTED] that she was being interviewed due to allegations that she used to be involved in a romantic relationship with a C/O at WCCW. Offender [REDACTED] agreed to participate in the interview.

Offender [REDACTED] stated that she was involved in a sexual relationship with Janice Jones in 1998. Offender [REDACTED] stated the relationship started at WCCW and became sexual when she released from prison. Offender [REDACTED] stated she kissed Jones several times at WCCW, but it never went further than kissing and touching. Offender [REDACTED] stated Jones used to change her jobs regularly so she could follow her around the facility when she was relocated to a different unit. Offender [REDACTED] stated Jones never brought contraband into her, but everyone considered her to be a "trick" and she did take care of all her bills. Offender [REDACTED] stated she was together with Jones for approximately a year before she was released from prison. Offender [REDACTED] added that Jones paid for her apartment off of Steele Street in Tacoma.

Offender [REDACTED] stated [REDACTED] and Jones were also involved in a relationship and it would "piss her off" when she called Jones from prison and offender [REDACTED] would pick up the phone. Offender [REDACTED] confronted offender [REDACTED] several times over the phone and eventually offender [REDACTED] and offender Jones "broke up." Offender [REDACTED] stated the last time she talked to Jones was in 2005.

Investigator Thrasher asked offender [REDACTED] if she had been involved in a relationship with C/O Roan. Offender [REDACTED] stated she never was involved in a relationship with C/O Roan and added that C/O Roan is a good officer. Offender [REDACTED] stated that several years ago she was at a club with Jones and C/O Roan was there with another female. Investigator Thrasher asked offender [REDACTED] what the name of the club was. Offender [REDACTED] declined to answer the question and declined to say who was at the club with C/O Roan. The only thing offender [REDACTED] said was that they all "drank" together.

Offender [REDACTED] stated she was telling the truth about C/O Roan and would participate in a polygraph examination to support her story.

Investigative Note: On 06/07/2006, Rick L. Minnich, Licensed Polygraph Examiner, attempted to polygraph offender [REDACTED] at WCCW. Offender [REDACTED] declined to participate. When asked why she declined, offender [REDACTED] stated, "When they asked me to take one, I didn't think they would really schedule it." (Attachment A)

Deborah Roan / Correctional Officer Washington Corrections Center for Women (WCCW) 08/17/2006 10:00 AM

Correctional Officer (C/O) Deborah Roan was interviewed by Investigator Thrasher on 08/17/2006, Investigator Baxter was also present. Investigator Thrasher explained to C/O Roan she was being interviewed due to allegations that she had engaged in a relationship with an offender while at WCCW and in the community. C/O Roan agreed to participate in the interview process and declined to have a union representative present.

Investigator Thrasher showed C/O Roan a picture of offender [REDACTED] and asked if she knew her. C/O Roan stated she knew offender [REDACTED] through a former C/O (Janice Jones) that had worked at WCCW until approximately 1997. C/O Roan stated she met her at a party that Jones had thrown at her residence.

Investigator Thrasher asked C/O Roan if she had been in a physical/emotional relationship with offender Roan. C/O Roan stated she had never been involved in any type of relationship with offender [REDACTED]

Investigator Thrasher asked C/O Roan if she had ever met any members of offender [REDACTED] family. C/O Roan stated she worked in the WCCW visiting room for four years and met her mother and daughter there. Offender Roan stated she had never met or seen offender [REDACTED] or any of her family in the community, including any soccer games.

Investigator Thrasher showed C/O Roan a picture of Kings Motor Inn located in Fife, WA (Attachment B) and asked if she had ever been to the hotel. C/O Roan denied ever entering or staying at the hotel with or without offender [REDACTED]

Investigator Thrasher asked C/O Roan if one of her family members had passed away in June of 1998. Offender Roan stated her sister had passed away and added she went back east to attend her funeral. Investigator Thrasher asked offender Roan who picked her up at the airport upon her return. Offender Roan stated her current partner, Marcia Jones, had picked her up at the airport. Offender Roan denied that offender [REDACTED] had picked her up at the airport and had taken her to a hotel room located on Highway 99 in SeaTac, WA.

Investigator Thrasher asked C/O Roan if she had been involved in an inappropriate relationship with offender [REDACTED] C/O Roan stated she was never involved in any type of relationship with C/O [REDACTED]

C/O Roan became upset during the interview and stated she has tattoos that she received while she was in the military. C/O Roan would not say how many tattoos she had but did say she has had them since 1991. Offender Roan asked if offender [REDACTED] had mentioned anything about her tattoos.

C/O Roan reiterated that she has always been professional in her job duties and denied having relationships with any offenders.

Offender [REDACTED] was interviewed on 08/17/2006 at 11:15 AM at WCCW, Investigator Thrasher and Investigator Baxter were present. Investigator Thrasher told offender [REDACTED] she was being interviewed so that additional information could be gathered regarding the allegations she had made. Offender [REDACTED] stated she understood and agreed to participate in the interview.

Investigator Thrasher asked offender [REDACTED] if she had knowledge of any tattoos that C/O Roan may have on her body. Offender [REDACTED] thought for a moment and stated she could not remember if C/O Roan had any tattoos or not.

Summary:

Based on information received, individuals interviewed and evidence collected, it has been determined that the allegations presented by offender [REDACTED] are unsubstantiated. Although a family member of [REDACTED] stated they met C/O Deborah Roan in the community, there is no physical information to support these claims. When interviewed, C/O Roan denied that she had been in any type of relationship with offender [REDACTED] at any time.
